I understand that the snowboard and snowshoe equipment being furnished forms a board/shoe system which is a **NON-RELEASE** system, and can not guarantee this user's safety for freedom from injury while using equipment. I further agree and understand that this ski/blade-boot-binding or board/shoe-boot does **NOT ELIMINATE THE RISK** of injuries to any part of this user's body.

I agree that I will release Marquette Mountain from any and all responsibility of liability for injuries or damages to the user of the equipment listed on this form, or to any other person. I agree NOT to make a claim against or hold liable Marquette Mountain for injuries or damages relating to skiing, snowboarding, snowblading, or snowshoeing and/or the use of this equipment.

I hereby agree to accept the terms and conditions of this contract. This document constitutes the final and entire agreement between Marquette Mountain and the undersigned. Marquette Mountain, itself, provides **NO WARRANTIES**, expressed or implied, and this rental equipment is accepted "as is."
